## The Durham City Regeneration Masterplan Summary response of the City of Durham Trust

The Plan is very similar to the City parts of the County Durham Plan.

- Similarly verbose, repetitive and unclear.
- Same uncritical identification of the City as motor of County economic growth.
- Same failure to recognise small size, fragility and special character of City and its Green Belt (e.g. paragraph 103 in section 2.12 of Chapter 2)

The Masterplan is built on the foundations of the County Durham Plan (CDP) and the Trust has spent most of the past eight weeks focussed on its responses to that document. As the CDP is fundamentally unsound in multiple ways, it follows that the Masterplan will need rewriting as the shortcomings in the CDP are identified and corrected.

Consequently, the Trust asks that its submissions on the relevant parts of the CDP (especially on the Core Policies 1-14 and Policy 25) are also taken as its response and objection to the Durham City Regeneration Masterplan in its current form.
