- 1. The *Duty to Cooperate Statement* should highlight the practical policy outcomes that have resulted<sup>1</sup> and the statement says at the top of page 7 that these are covered in Appendix 3. However, while Appendix 3 identifies the issues, says which forum is addressing them, and says whether they are a priority, it does not actually highlight any practical policy outcomes. Nor can we find them elsewhere in the Statement. For example:
  - a) There is no evidence that the population figures for County Durham have been prepared in collaboration with neighbouring authorities. It appears that each authority is seeking to maximise its own population: Durham County Council is looking to achieve an **11.2% increase** in the county's population between 2011 and 2030. This needs to be put in the context of the latest ONS projection of a 5.9% growth in the population of the north-east region over the same period. As Durham County accounts for about 20% of the population of the wider region, growth at the rate projected by the Council implies a significant lowering of projected growth elsewhere in the region, unless there is a substantial increase in inward migration from outside the region to the whole of the north-east.
  - b) There is no evidence that the related housing requirement has been assessed taking into account neighbouring authorities' assessments.
- 2. Furthermore, the vast majority of the examples cited in Appendix 3 are of officer-level engagement. Evidence that the political leadership of Durham County Council and of the partner authorities have altered the content and implementation of their respective local policies to reflect this officer-level dialogue is not provided.
- 3. The Pre-Submission Draft does not include any reference to the North East Leadership Board which it is intended will take over transport functions, and share economic growth functions, on 1 April 2014. While the NELB is not yet in place, it will be before the Examination in Public, and yet the implications of this on the implementation of the plan have not been addressed. In more detail:
  - a) On Monday 24 June 2013 the Cabinets of seven north-eastern local authorities (Durham, Gateshead, Newcastle, North Tyneside, Northumberland, South Tyneside and Sunderland) all met and each resolved that a Combined Authority (CA) would be established pursuant to section 103 of the Local Democracy, Economic Development and Construction Act 2009 ("LDEDCA"), to come into existence on 1 April 2014. This body will be called the North East Leadership Board (NELB)<sup>2</sup>.
  - b) As the report says at paragraph 3, a Combined Authority is a legal structure to lead collaboration between local authorities and enable strategic decision-making on economic growth and transport. They are designed to enable groups of local

authorities to work closely together to deliver improvements in economic growth and transport across local authority boundaries.

- c) The NELB will share economic growth functions with the constituency authorities.
- d) The strategic transport functions currently undertaken across Tyne & Wear and Northumberland and Durham will be undertaken by the NELB. These will include preparation of the Local Transport Plan and public transport functions. On the creation of the Combined Authority it will become a levying authority for transport functions.
- e) Neither of the terms 'Combined Authority' or 'North East Leadership Board' occurs in the Pre-Submission Draft and we conclude that the consequences of its creation have not been taken into account when the Plan was being prepared.
- f) Obviously, since the NELB does not yet exist, it could not be consulted at this stage. But, assuming that Parliament makes the necessary Order, it will be in place before the Examination in Public. The Secretary of State for Communities and Local Government is currently (since 7 November 2013) consulting on the proposals<sup>1</sup> with a closing date of 2 January 2014. The draft statutory instrument has an implementation date of 1 April 2014.
- g) Paragraph 181 of the NPPF states "Cooperation should be a continuous process of engagement from initial thinking through to implementation, resulting in a final position where plans are in place to provide the land and infrastructure necessary to support current and projected future levels of development."
- h) The Plan includes descriptions of how the various policies will be implemented, how it will be monitored and what the targets are. These should have taken account of the impact of the creation of the NELB. The most obvious effect will be on the transport aspects of the Plan at policies 48, 49 and 50, which will be taken out of the Council's hands. Policies 9 and 10 relating to the Durham Relief Roads would presumably need to be justified in any emerging combined Transport Plan. The economic aspects of the Plan will need to be reviewed to determine how their implementation will change on creation of the NELB.
- 4. The *Duty to Cooperate Statement* does refer to the NELB in two places: On page 8 is a description of moves to establish it, as set out above. However, on page 17 the reference is preceded by the phrase "exploring the option" and we infer that this was written at an earlier stage and not updated.
- 5. The only references to the Duty to Cooperate in the Pre-Submission Draft are at paragraphs 8.27 (coastal management and planning), 10.59 (supply of brick-making raw materials) and 10.95 (waste management). We would have expected to see evidence of cooperation much more widely, certainly in chapters 7 (Housing) and 9 (Transport and Infrastructure).
- 6. The foregoing overarching comments are supplemented in our critiques of individual policies where these fail to demonstrate cooperation that might reasonably be required.
